Background

Summary of organisation and management structure:

- CEO Mr Hassan Younes and Training Manager, Mrs Sarifa Younes took ownership of RTO in October 2015, following initial registration in June 2015, adding the child care qualifications.
- From 2004 they have owned and operated Arndell Park Early Childhood Learning Centre, at the same address,. The child care centre website acknowledges a partnership with Training College of Australia (trading name of RTO) and there is a documented MOU regarding business arrangements.
- At the time of audit the RTO had 7 current students and had issued 2 Qualification certificates and 92 statements of attainment for single first aid related units of competency, in the last 12 months.
- Both CEO and Training Manager undertake training and assessment activities, additional trainers are not currently required.
- All student work placement is undertaken at Arndell Park Early Childhood Learning Centre.
